DEED OF TRUST

NOW, THEREFORE for the purpose of securing each agreement of the Trustor herein contained including payment of the said promissory note and of any money with interest thereon that may be advanced by or otherwise become due to Trustee or Beneficiary under the provisions hereof and for the purpose of securing payment of such additional sums as may be hereafter be advanced for the account of Trustor by Beneficiary with interest thereon.

TRUSTOR irrevocably GRANTS AND TRANSFERS TO TRUSTEE, in TRUST WITH POWER OF SALE, all that property in Lincoln County, Nevada described as: (Set forth legal description and commonly known street address, if known)

A parcel of Land situate within the SW ¼ of the NW ¼ of Section 8, Township 4 South, Range 67 East, Mount Diablo Meridian, being more particularly described as follows:
Beginning at the Southwest Corner of this parcel from which the Southwest Corner of said Section 8 bears S 07 degrees 17' 33" a distance of 3,809.60 feet; Thence due North a distance of 201.78 feet to the Northwest Corner; Thence S 89 degrees 54' 05" E a distance 233.93 feet; Thence 58 degrees 03' 00" E a distance of 135.51 feet; thence S 17 degrees 21' 54" W a distance of 243.95 feet; Thence S 02 degrees 43' 54" W a distance of 54.43 feet; Thence N 80 degrees 42' 00" W a distance 582.06 feet which is the point of beginning. Such provisions so incorporated shall have the same force and effect as though specifically set forth and incorporated in this Deed of Trust.

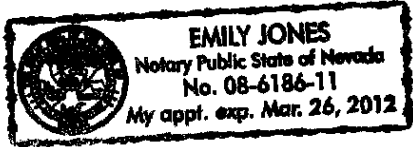
