One Hundred Seventy Two Thousand Sixty Eight Dollars and no cents (\$172,068.00)
Together with interest from date at the rate of .05625 per cent (.05625%) per annum on the unpaid principal, said principal and interest payable as follows:
One thousand Dollars, and no cents per month. (\$1,000.00)

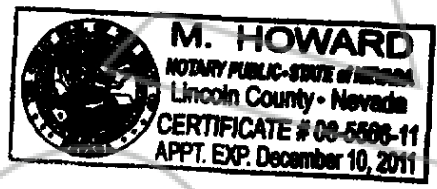
