TEMPORARY CONSTRUCTION EASEMENT

THIS instrument is made this 20th day of November, 2009 by and between UNION PACIFIC RAILROAD COMPANY, a Delaware Corporation, successor in interest to the SAN PEDRO, LOS ANGELES & SALT LAKE RAILROAD COMPANY ("Grantor"), and the STATE OF NEVADA, acting by and through its DEPARTMENT OF TRANSPORTATION ("Grantee"):

WITNESSETH:

1. Grantor, for and in consideration of the sum of Three Thousand Three Hundred Ninety-Four Dollars (\$3,394.00) and in consideration of and subject to the mutual covenants contained herein, hereby grants to Grantee, its successors and assigns, temporary construction easements upon and across the property located in Lincoln County, State of Nevada described below (the "Property") for a period of thirty-six (36) months or until completion of the Project, whichever occurs earlier, commencing on the Effective Date of the separate Agreement for Right-of-Way Grant Covering Roadway Construction, Reconstruction and Maintenance of SR317 – Rainbow Canyon Near Caliente, Lincoln County, Nevada dated November, 20, 2009 (the "C&M Agreement"), covering the construction and maintenance of the highway identified as SR317 as located between Grantor's Mileposts 440.3 and 459.1 on Grantor's Caliente Subdivision.

Situate, lying and being in the County of Lincoln, State of Nevada, and more particularly described as being a portion of that Right-of-Way Grant, CC 00360, issued by the Department of the Interior, Bureau of Land Management on April 20, 1906, located in the NE 1/4 of Section 1, T. 7 S., R. 66 E., M.D.M., and more fully described by metes and bounds as follows, to wit:

BEGINNING at the intersection of the right or easterly right-of-way line of SR-317 with the westerly 100 foot right-of-way line of the Union Pacific Railroad at approximate Railroad Milepost 440.1, 45.00 feet right of and at right angles to Highway Engineer's Station "X1" 178+51.76 P.O.T.; said point of beginning further described as bearing N. 2°48'40" E. a distance of 3,399.77 feet from the south quarter corner of said Section 1; said corner further described as being a 2.5" GLO BRASS CAP ON A 1" PIPESTEM IN A 3' COLLAR OF STONES, STAMPED "1/4 S1/S12 1920"; thence N. 14°35'54" W., along said right or easterly right-of-way line of SR-317, a distance of 238.61 feet to said westerly railroad right-of-way line; said Railroad right-of-way line further described as being 100 feet west of and parallel to the Union Pacific Railroad centerline from approximate Railroad Station 1026+64.3 P.T. to 1021+59.9 P.S., said centerline further described as being a spiral curve with a 6°00' of Curvature (chord definition) with a total central angle of 19°25'08" and spiral segments of 5°24' and lengths of 180,00 feet: thence along said westerly railroad right-of-way line, subtended by the chord N. 6°44'15" W. a distance of 143.02 feet; thence along said railroad right-of-way line, subtended by the chord N. 5°12'56" W. a distance of 143.32 feet; thence along the following three (3) courses and distances:


thence S. 8°59'51" E., along said easterly railroad right-of-way line, a distance of 85.35 feet to the point of beginning; said parcel contains an area of 34,537 square feet (0.79 of an acre).

The Basis of Bearing for these descriptions is the NEVADA STATE PLANE COORDINATE SYSTEM, NAD 27 DATUM, East Zone as determined by the State of Nevada, Department of Transportation.

2. RESERVING, however, unto the Grantor, its successors and assigns, the right to construct at any and all times and to maintain railroad tracks, track appurtenances, fiber optic or signal lines and facilities, pipe, telephone, and electric pole and wire lines, over, under and across the Property, but in such a way as to not unreasonably interfere with Grantee's use of the Property for the purposes specified herein; it being understood that the rights so reserved unto the Grantor, its successors and assigns, are retained along with the general right of the Grantor, its successors and assigns, to the use of the Property for any purpose not inconsistent with Grantee's use of the

Property, for the purposes herein defined, including, but not limited to, any and all general railroad purposes.

- 3. This grant of a temporary construction easement is also made SUBJECT to (i) the terms and conditions of the separate C&M Agreement, covering the construction and maintenance of the highway, (ii) all valid outstanding and pre-existing leases, licenses and other outstanding rights, including, but not limited to, those for pipelines, wirelines, fiber optic lines and facilities and the right of renewals and extensions of the same, and (iii), all outside and pre-existing conditions, limitations, restrictions, encumbrances, reservations or interests of any person or entity which may affect the Property, whether recorded or unrecorded, and the word "grant" as used herein shall not be construed as a covenant against the existence of any thereof.
- 4. The temporary construction easement rights granted herein are also limited to such rights as the Grantor may have in the Property and are granted without warranty, express or implied.
