PLEASE TAKE NOTICE THAT the State of Nevada, Department of Health & Human Services Division of Health Care Financing and Policy, an agency of the State of Nevada, whose central office is 1000 East Williams Street, Suite 102, Carson City, Nevada 89701, by and through its counsel, Catherine Cortez Masto, Attorney General, and RENE L. HULSE, Deputy Attorney General, claims a lien pursuant to the provisions of NRS 422.29306 and NRS 108.850 to 108.870, and the ORDER IMPOSING MEDICAID LIEN ON REAL PROPERTY attached hereto and incorporated herein by this reference, upon the property described as follows:

PARCEL 1 of that Parcel Map for Hulda & Lawrence E. Sharp in the town of Alamo, Lincoln County, Nevada, in SW ¼ SE ¼ Section 5, Township 7 South, Range 61 East, Mount Diablo Meridian, recorded as file No 118103, Plat B, Page 428 on May 6, 2002, in the office of the Lincoln County Recorder, Lincoln County, Nevada. and commonly known as 167 Broadway Street, Alamo, Lincoln County, Nevada, 89001.

The lien is placed for reimbursement of Medicaid benefits paid on behalf of HULDA R. SHARP in the amount of **fourteen thousand eight hundred twenty-seven dollars and fourteen cents (\$14,827.14)** to be paid to Nevada State Division of Health Care Financing and Policy upon sale or transfer of the property.

However, pursuant to State and Federal law, the State may only recover on such a lien at a time when there is no surviving spouse, child(ren) under 21, or blind and/or disabled children of any age, if any. Additionally, the State must release its lien if the surviving spouse, child under 21 or disabled child, if any, seeks to engage in a bona fide sale or financial transaction involving the home. The object of the pending lien action is to secure the State's interest in the property and also allow the survivors to enjoy and benefit from their interest in and use of the property.



18 **ORDER IMPOSING MEDICAID LIEN ON REAL PROPERTY**

19 THIS MATTER came before this Court on January 8, 2010, upon the Petition of the
20 STATE OF NEVADA, DEPARTMENT OF HEALTH AND HUMAN SERVICES, DIVISION OF
21 HEALTH CARE FINANCING AND POLICY ("NEVADA MEDICAID"), by and through
22 CATHERINE CORTEZ MASTO, Attorney General of the State of Nevada, by and through
23 Rene L. Hulse, Deputy Attorney General. Rene Hulse appeared on behalf of Nevada
24 Medicaid, Dylan V. Frehner, Esq., appeared on behalf of Lola Sharp, Mary Ann Sharp, and
25 Lawrence E. Sharp, and Joseph Sharp appeared in proper person. Having received the
26 evidence, the Court finds as follows:

- 27 1. All notices as required by law have been provided.
28 2. HULDA SHARP, deceased, was the recipient of Medicaid benefits from August

1 1, 2008, through November 23, 2008, her date of death.

2 3. The State of Nevada Medicaid Program provided payment for medical services
3 for HULDA SHARP in the amount of **fourteen thousand eight hundred twenty-seven**
4 **dollars and fourteen cents (\$14,827.14)** through May 27, 2009.

5 4. The undivided estate of HULDA SHARP included real property having the
6 common address of 167 Broadway Street, Alamo, Lincoln County, Nevada, 89001, and
7 having the legal description of:

8 PARCEL 1 of that Parcel Map for Hulda & Lawrence E. Sharp in the town
9 of Alamo, Lincoln County, Nevada, in SW ¼ SE ¼ Section 5, Township 7 South,

11 As the trustee of the Sharp Living Trust, HULDA SHARP held a 100% ownership interest in

13 5. Imposing a lien upon HULDA SHARP's interest in the above-described real
14 property in the amount **fourteen thousand eight hundred twenty-seven dollars and**
15 **fourteen cents (\$14,827.14)** in favor of Nevada Medicaid is authorized and appropriate
16 pursuant to Nevada Revised Statutes.

17 **THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED, ADJUDGED,**


