10th day of June, 2009This claim occupies the **NE $\frac{1}{4}$ of Section 10, T. 2 S., R. 68 E., MDB&M, Lincoln County, Nevada** and contains **130 acres** more or less which excludes those lands which are part of CC023544, Road and Right of Way, and all non-contiguous lands south of CC023544 which are within the Aliquot Part of the Rectangular Survey.

The claim has been located by reference to the legal subdivision in a surveyed township pursuant to 43 CFR 3832.12(c) and excludes those lands which are part of CC023544, Road and Right of Way. (2640 feet in a East/West direction with the West boundary 1873 feet in a North/South direction, the East boundary 2400 feet in a North/South direction). The location monument consists of a 2x2 wooden post set one foot into the ground and situated in the northeast corner of the claim. The name of the claim is marked with a permanent marker. The work of location consisted of making the maps as provided in NRS 517.100. This claim has been located for the purpose of appropriating placer minerals.
