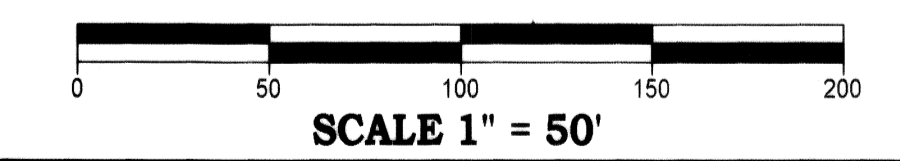
DETAIL B
