### AN ORDINANCE

OF THE CITY COUNCIL OF THE CITY OF MESQUITE, NEVADA, AMENDING TITLE 1 OF THE MESQUITE MUNICIPAL CODE ENTITLED "ADMINISTRATION", BY REVISING SECTION 1-8-18 CITY LIMITS DESIGNATED AND EXTENDING THE CITY LIMITS OF THE CITY BY ANNEXING THERETO APPROXIMATELY 2,598± ACRES (LINCOLN HIGHLANDS - PHASE ONE, ANNEXATION CASE NO. AX-10-001); AND BEING MORE PARTICULARLY DESCRIBED HEREIN.

WHEREAS, the City of Mesquite, Nevada ("the City") was duly created in 1984 under General Law pursuant to the provisions of Chapter 266 of Nevada Revised Statutes; and

WHEREAS, the governing body of the City of Mesquite, Nevada is the Mesquite City Council; and

WHEREAS, Nevada Revised Statutes ("NRS") Section 268.580 establishes general standards and NRS Section 268.597 sets alternative procedures for annexing territory by an incorporated City; and

WHEREAS, NRS Section 268.597(1.)(a.) authorizes the City to annex the described territory ("Annexation Area") since the landowners have signed a petition constituting one hundred percent (100%) of the owners of record of individual lots or parcels on land within the annexation area; and

WHEREAS, the total area to be annexed shown in Exhibit "A" meets the standards provided by law for annexation to the City under NRS Section 268.580(2.) in that a) the area to be annexed was contiguous to the City's boundaries at the time the annexation proceedings were instituted; b) more than one-eighth of the aggregate external boundaries are contiguous to the boundaries of the City; c) the territory proposed to be annexed is not included within the boundaries of another incorporated city as those boundaries exist on July 1, 1983; and d) the territory proposed to be annexed is not included within the boundaries of any unincorporated town as those boundaries exist on July 1, 1983.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE AS FOLLOWS:

**SECTION 1**: Title 1, Chapter 8, Section 18 of the Mesquite Municipal Code is hereby amended to add a new Subsection (E) thereto to read as follows:

## 1-8-18: CITY LIMITS DESIGNATED:

E. Additions to the City Limits: The City Limits of the City shall be enlarged by 2,598± acres, to include the following area:

PORTIONS OF SECTIONS 20, 21, 28, 29, 30, 31, 32, 33 AND 34 OF TOWNSHIP 12 SOUTH, RANGE 71 EAST, M.D.M., LINCOLN COUNTY, NEVADA, DESCRIBED AS FOLLOWS:

COMMENCING AT MILE POST 311 ON THE NEVADA-ARIZONA STATE LINE. AS SHOWN IN THE PLAT BY THE BUREAU OF LAND MANAGEMENT (BLM) INDEPENDENT RESURVEY OF TOWNSHIP 12 SOUTH, RANGE 71 EAST, ACCEPTED ON JULY 24, 2001; THENCE ALONG SAID STATE LINE N01°08'00"W A DISTANCE OF 116.09 FEET TO THE SOUTHEAST CORNER OF GOVERNMENT LOT 8 OF SAID SECTION 34; THENCE DEPARTING SAID STATE LINE. ALONG THE EAST LINE OF THE W 1/2 OF SECTION 28, S00°01'40"W A DISTANCE OF 5,280.00 FEET TO THE NORTHEAST CORNER OF THE NW 1/4 OF SAID SECTION 33: THENCE DEPARTING SAID EAST LINE OF THE W 1/2 OF SECTION 28, ALONG THE EAST LINE OF SAID NW 1/4 OF SECTION 33, S00°01'22"W A DISTANCE OF 2,640.00 FEET TO THE NORTH LINE OF THE NORTH HALF (N 1/2) OF SAID SE 1/4 OF SECTION 33; THENCE DEPARTING SAID EAST LINE OF THE NW 1/4 OF SECTION 33, ALONG SAID NORTH LINE OF SAID N 1/2 OF THE SE 1/4, S89°57'25"E A DISTANCE OF 2,639.56 FEET TO THE NORTHWEST CORNER OF GOVERNMENT LOT 7 OF SAID SECTION 34; THENCE DEPARTING SAID NORTH LINE OF SAID N 1/2 OF THE SE 1/4, ALONG THE NORTH LINE OF SAID LOT 7. S89°58'37"E A DISTANCE OF 1,544.61 FEET TO THE NORTHEAST CORNER OF SAID LOT 7: THENCE DEPARTING SAID NORTH LINE OF LOT 7. ALONG THE EAST LINE OF SAID LOT 7, S01°08'00"E A DISTANCE OF 1,320.53 FEET TO THE SOUTHEAST CORNER OF SAID LOT 7, THENCE DEPARTING SAID EAST LINE OF LOT 7, ALONG THE SOUTH LINE OF SAID LOT 7, N89°58'03"W A DISTANCE OF 1,571.50 FEET TO THE SOUTHEAST CORNER OF SAID N 1/2 OF THE SE 1/4 OF SECTION 33; THENCE DEPARTING SAID SOUTH LINE OF LOT 7, ALONG THE SOUTH LINE OF SAID N 1/2

OF THE SE 1/4 OF SECTION 33, N89°56'08"W A DISTANCE OF 2,639.32 FEET TO THE EAST LINE OF SAID SW 1/4 OF SECTION 33; THENCE DEPARTING SAID SOUTH LINE OF SAID N 1/2, ALONG SAID EAST LINE OF THE SW 1/4 OF SECTION 33, S00°01'22"W A DISTANCE OF 1,319.01 FEET TO THE **POINT OF BEGINNING**.

CONTAINING 2,598 ACRES, MORE OR LESS.

**SECTION 2:** That, pursuant to NRS 268.597(1)(a), the Annexation Area is hereby annexed to and made a part of City of Mesquite, Nevada upon completion of those requirements set forth in Section 3 following.

SECTION 3: That the City staff are hereby directed, pursuant to NRS 268.600, as follows: 1) The City staff shall record a certified copy of this ordinance, with an accurate map or plat of the Annexation Area prepared under the supervision of a competent surveyor or engineer attached thereto, in the Office of the Lincoln County Recorder and, if necessary, the Clark County Recorder, prior to December 10, 2010, the effective date of the annexation; and 2) the City Clerk's Office shall file a duplicate copy of the same with the Nevada Department of Taxation,

SECTION 4: The City of Mesquite shall not be required to pay for the extension of municipal services to the territory annexed, but intends that municipal services shall be extended at the expense of the property owners and according to demand, need and benefit of the respective property owners, and in accordance with the policies, Code, and the applicable provisions of Nevada Revised Statutes. As development occurs, the City will furnish police and fire protection and maintenance of installed, improved and accepted utilities, streets and public recreation facilities in the Annexation Area.

SECTION 5: The Annexation Area, which previously has been zoned Planned Unit Development (PUD) (County of Lincoln classification) is hereby classified as PUD (City of Mesquite classification), which is deemed to be the City equivalent of the County classification. Until such time as a specific Master Development Plan, Development Agreement, and Design Standards Handbook are adopted per Mesquite Municipal Code (MMC) Section 9-7U, the Lincoln Highlands PUD zoning shall be comparable to uses and density provided under the Land Reserve (LR) zone.

SECTION 6: Prior to adoption of a specific Master Development Plan, Development Agreement, and Design Standards Handbook for the Annexation Area, the Lincoln Highlands PUD must include a distribution and phasing plan for land uses and infrastructure, and a financing plan for infrastructure that describes what is needed, how much it will cost, and how it will be funded.

**SECTION 7:** If any section, paragraph, clause or provision of this ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall in no way affect remaining provisions of this ordinance.

**SECTION 8:** All ordinances, parts of ordinances or chapters, sections or paragraphs contained in the Mesquite Municipal Code in conflict herewith are hereby repealed,

**SECTION 9:** EFFECTIVE DATE. The annexation of the described territory shall become effective on the 10<sup>th</sup> day of December, 2010, which meets the provisions of NRS 268.596(4). On the effective date, the City will have funds appropriated in sufficient amount to finance the extension into the undeveloped Annexation Area of police protection, fire protection, street maintenance, street sweeping, and street lighting maintenance.

**SECTION 10**: The Annexation Area, together with the inhabitants and property thereof, shall, from and after the 10<sup>th</sup> day of December, 2010, be subject to all debts, laws, ordinances and regulations in force in the City and shall be entitled to the same privileges and benefits as other parts of the City, and shall be subject to municipal taxes levied by the City.

**SECTION 11:** A copy of this Ordinance shall be filed with the office of the City Clerk, and notice of such filing shall be published once by title, in a newspaper having general circulation in the City of Mesquite at least ten (10) days prior to the adoption of said Ordinance.

**SECTION 12:** PUBLICATION. The City Clerk shall cause this ordinance to be published once immediately following its adoption, by title, in a newspaper qualified pursuant to provisions of Chapter 238 of NRS, as amended from time to time.
