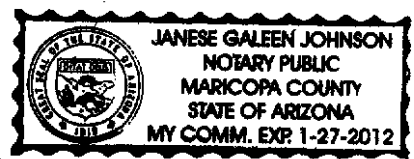

1. This certification of waiver from payment of maintenance fees is made under the regulations at 43 CFR 3833 and 3836.
