Mr. Marcantonio:

As a follow-up to our conversation on Friday January 14, 2011 I have put together an offer for your consideration on the sale of mining claims in Nevada. The details are as follows:

OFOR SILVER, LLC is the registered owner of the following patented mining claims in Lincoln County, State of Nevada.

Sections 16,17,20 and 21, Township 7 North., R.68. East, Roadside Claim, 20.34 acres

OFOR SILVER LLC, a Utah company owned and controlled by Boyd Knight is open to offers to sell the above named properties. At this time the offer to sell is made exclusively to George Marcantonio who currently has a Lease agreement which terminates on the Eighth (8th) day of June 2011. In the event that Mr. Marcantonio wishes to terminate the Lease he can do so by written notification to OFOR SILVER at the above address.

OFOR SILVER will consider offers to buy the above properties and surrender all title to the properties for the following amount: 61.02 acres at \$370.00 per acre for a total cash price of \$22,577.40. In addition to the purchase price is the stipulation of a royalty payment of ten percent (10%) on any mineral production from the above property.

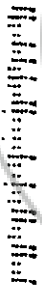
