LEASE TERMINATION AGREEMENT

THIS LEASE TERMINATION AGREEMENT ("Agreement") is entered into as of the day of June, 2011 ("Effective Date"), by and between GEORGE MARCANTONIO ("Lessee") and OFOR SILVER, LLC, a Utah limited liability company ("Lessor"), collectively referred to as the "Parties."

RECITALS

- A. The Parties entered into a written Mining Lease dated June 8, 2010 (the "Mining Lease"), which Mining Lease concerns the real property located in Lincoln County, Nevada described in Exhibit A hereto and referred to herein as the "Property."
 - B. The Parties mutually desire to terminate the Mining Lease as provided herein.

AGREEMENT

- 3. Return of Geologic Data. Lessee shall, within ten days after its execution of this Agreement and for no additional consideration, return to Lessor (without retaining any copies thereof) all geologic, technical and other data and records regarding the Property that were provided to Lessee by Lessor in connection with the Mining Lease, including without limitation any assays, drill core and cuttings, drill logs, samples, maps, surveys, geochemical and geophysical studies, ore reserve estimates, engineering studies, economic evaluations, metallurgical and processing studies and exploration records.
- 4. <u>Construction of Agreement</u>. This Agreement constitutes the entire understanding of the Parties with respect to the subject matter hereof and supersedes all negotiations, representations, prior discussions and preliminary agreements between the Parties relating to the subject matter hereof. No modification or alteration of this Agreement shall be effective unless made in writing and executed by the Parties with the same formality as this Agreement. This Agreement and each provision hereof shall be construed as though both Parties participated equally in its drafting.
- 5. <u>Execution</u>. This Agreement may be executed in multiple counterparts, which taken together shall constitute one and the same document even though both Parties do not sign the same counterpart.


