## RIGHT-OF-WAY-EASEMENT

KNOWN ALL MEN BY THESE PRESENTS, that Chester W. & Joanna Turnbull, the undersigned, for a good and valuable consideration, the receipt whereof is hereby acknowledged, do here by grant unto LINCOLN COUNTY POWER DISTRICT NO. 1, a municipal corporation of the State of Nevada, whose post office is Pioche, Nevada, and to its successors or assigns, the right to enter upon the lands and premises of the undersigned, situated in the County of Lincoln, State of Nevada, and more particularly described as follows:

A 20 foot wide overhead powerline easement (10 feet on each side of the following centerline) within Tracts 13 & 14 of the Map of Division of Large Parcels recorded Document Number 110618 in Plat Book B at Page 364 of the Lincoln County Records and located in Section 3 of Township 3 South, Range 67 East, M.D.M. which easement is shown on the Record of Survey, Document Number 0/38647 in Plat Book D at Page 47 and more particularly described as follows:

Beginning on the easterly boundary of Tract 13 at a point from which the southwest corner of said Section 3 bears S 58°27'19" W 1678.42';

Thence S 85°02'28" W 328.79' to an angle point, which angle point retains a 35' semicircle on the southerly side of said centerline for structural support as needed; Thence N 76°43'26" W 416.18' to the westerly boundary of Tract 13 and continuing 657.70' into Tract 14, which includes a 35 foot extension for structural support purposes.
