MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT ("Memorandum") is entered into by and among Coyote Springs Investment LLC, a Nevada limited liability company ("CSI"), Western Lands Project, a State of Washington non-profit corporation, ("WLP"), and Nevada Outdoor Recreation Association, Inc., a Nevada non-profit corporation ("NORA"), as of September 1, 2011. As used herein, each of CSI, WLP and NORA may also be referred to as a "Party" and collectively, the "Parties."

WHEREAS, CSI is the master developer of the Coyote Springs - Clark County Project and the Coyote Springs - Lincoln County Project which are referred to collectively herein as the "Coyote Springs Development."

WHEREAS, CSI is the record owner of certain lands and in fee and will be the future record owner of certain fee lands that are presently held by lease within Clark County and Lincoln County, Nevada, that will be utilized for the Coyote Springs Development are described on Exhibit A attached hereto and incorporated herein ("Subject Land").

WHEREAS, the Parties hereto desire to record this Memorandum against the Subject Land to provide notice of certain agreements among the Parties.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt thereof is hereby acknowledged, the Parties hereto mutually agree as follows:

- This Memorandum shall be recorded against the Subject Land for the purpose of giving notice that certain mitigation fees must be paid by CSI to a Development Mitigation Fund upon commencement of grading the subject acreage.
- 2. This Memorandum shall be subordinate to all liens and encumbrances of record prior to the time that this Memorandum is recorded in the Official Records of Clark County or Lincoln County, Nevada, as applicable.
- This Memorandum shall not encumber any lands described as leased lands on Exhibit A 3. hereto unless and until such time as the fee interest is conveyed to CSI by the United States of America.
- WLP and NORA shall record a release of this Memorandum from time to time for any and all acreage for which the mitigation fee has been paid to the Development Mitigation Fund. Each release shall be in recordable form and be delivered immediately upon receipt of the funds by the Development Mitigation Fund.
- This Memorandum shall be governed by and construed under the laws of the State of 5. Nevada, excepting therefrom the conflict of laws provision.
