SUBORDINATION AGREEMENT

This Subordination Agreement ("Agreement") is made this Twelfth day of November, 2012, by MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR QUICKEN LOANS INC., ITS SUCCESSORS AND/OR ASSIGNS ("Subordinating Lender"), a corporation whose address is NC4-105-01-38, 4161 Piedmont Parkway, Greensboro, NC 27410.

WHEREAS, Subordinator is the beneficiary/mortgagee of that certain Deed of Trust/Mortgage ("Security Document") pursuant to that certain Security Document dated 06/08/2007 (the "Senior Lien"), and executed by RILEY L. BARNES and MACALL BARNES and encumbering that certain real property located at 101 KEELE RD, CALIENTE, NV 89008 (address) which is legally described on Exhibit "A" attached hereto and incorporated herein (the "Property"), which Security Document was recorded on 07/18/2007 in Official Records Book N/A, Page N/A, as Instrument No. 0129245, of the Official Records of LINCOLN County, Nevada, as the same may have been or is to be modified prior hereto or contemporaneously herewith.
