The Discovery Monument is located NORTH 57 DEGREES 10 MINUTES 31 SECONDS EAST, A DISTANCE OF 16,670 SFEET From the following natural/permanent monument: NE CORNER OF SECTION 15 T 2N R 65E

The claim is approximately 1500 feet long and 600 feet wide, such that 300 feet are claimed in a SOUTH direction and 1200 feet in a NORTH direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the NORTH to the SOUTH direction.
