The Discovery Monument is located NORTH 80 DEGREES 28 MINUTES 44 SECONDS WEST, A DISTANCE OF 2,687 SFEEET From the following natural/permanent monument: LOCATED AT THE SE CORNER OF SECTION 36 T4N R65E

The claim is approximately 1500 feet long and 600 feet wide, such that 300 feet are claimed in a WEST direction and 1200 feet in a EAST direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the EAST to the WEST direction.
