The Discovery Monument is located NORTH 77 DEGREES 16 MINUTES 0 SECONDS EAST A DISTANCE OF 8,462 SFEET From the following natural/permanent monument: LOCATED AT THE NW CORNER OF SECTION 1 T1S R67E

The claim is approximately 1500 feet long and 600 feet wide, such that 700 feet are claimed in a WEST direction and 800 feet in a EAST direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the WEST to the EAST direction.
