

FINDINGS OF FACT AND CONCLUSIONS OF LAW

- 1.(X) The State of Nevada has/is taking continuing exclusive jurisdiction pursuant to the Full Faith and Credit Support Orders Act (28 U.S.C. 1738b)
- 2.(X) The Court has jurisdiction of the parties and of the subject matter of this case.
- 3. () The parties and the child(ren) reside outside the State of Nevada.
- 4.(x) No child support order exists for the support of the minor child(ren).
- 5.(X) The Obligor is the parent of the following child(ren): NAME(S)

- 6.(X) The Obligor has a duty to support the above named
 child(ren);
- 7.(x) The Obligor owes support arrears to the Obligee in the amount of $$\frac{400.00}{}$ from $\frac{7-1-12}{}$ through $\frac{10-31}{}$, 2012.
- 8. (X) Benefits have been received on behalf of the minor child(ren) in the form of: (X) Medicaid (X) TANF

12. (x) Genetic testing has confirmed that the Obligor is the biological father of the minor child(ren), therefore the Master finds the Obligor is the legal father of said child(ren).

13. (X) The obligor was personally served with Notice of Financial Responsibility on September 20, 2012.

OTHER FINDINGS:

Given the Obligor's ability to pay and health condition, no interest shall be charged based upon an undue hardship. The parties obtained genetic testing on their own behalf; said results determined that the Obligor is the biological father of the child. A copy of the results shall be provided to the State.

IT IS HEREBY RECOMMENDED THAT:

- 1. (x) The Obligor shall pay \$100.00 per month as and for ongoing child support, beginning 11-1, 2012.
- a. (x) Medical Cash is owed and the Obligor is to pay \$_5.00 per month beginning _11-1, 2012 and continuing until private insurance is obtained and the child is off Medicaid or coverage under the current policy lapses.
- 2. (x) A judgment of support arrears is entered in favor of the Obligee and against the Obligor in the amount of $\frac{400.00}{1000}$ from $\frac{7-1-12}{1000}$ through $\frac{10-31}{1000}$, 2012. Obligor is to pay $\frac{20.00}{1000}$ per month beginning $\frac{11-1}{1000}$, 2012 and also continuing each and every month thereafter until paid in full.
- 3. ALL PAYMENTS NOT COLLECTED BY INCOME WITHHOLDING SHALL BE MADE BY MONEY ORDER, CASHIER'S CHECK, OR BUSINESS CHECK AND PAYABLE TO "SCADU". PERSONAL CHECKS WILL NOT BE ACCEPTED. NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO THE OBLIGEE. ALL SUCH PAYMENTS SHALL CONTAIN THE OBLIGOR'S NAME (PAYOR), OBLIGOR'S SOCIAL SECURITY NUMBER, CASE NUMBER, AND THE OBLIGEE'S NAME (PAYEE) ALL SUCH SHALL BE PAYABLE AND MUST BE DELIVERED BY THE OBLIGOR TO:

- 4.() The Obligor shall provide health insurance coverage that is reasonable in cost and accessible for the child(ren) through:
 - a. Obligor's employer or group policy; or
 - b. private policy; or
- c. any other means available to Obligor, other than Medicaid.
- 5.(x) The Obligee is required to provide health insurance coverage at this time because () it is available at this time and/or (x) she is receiving Medical Cash compensation. Further, Obligee shall provide all reasonable and necessary assistance to enable the Obligor to obtain the medical benefits offered by the policy of insurance pursuant to NRS 125B.085.
- 6. Pursuant to NRS 125B.080.7, expenses for health care which are not reimbursed through insurance, including expenses for medical, surgical, dental, orthodontic and optical expenses, must be borne equally by both parents in the absence of extraordinary circumstances.
- 7. The Obligor shall notify the Family Support Unit of the District Attorney's office of any change of address, change in employment or change in the availability of health insurance coverage within ten (10) days of such coverage.
- 8. THIS IS AN INCOME WITHHOLDING ORDER. A mandatory wage withholding shall be initiated against the Obligor's wages or commissions. This does not preclude the use of other means to collect any arrears or enforce this order, including garnishment, liens, attachments, execution on real or personal property or interception of Federal Income tax refunds.
- 9. NO CREDIT WILL BE GIVEN FOR PAYMENTS NOT MADE BY WAGE/INCOME WITHHOLDING OR DIRECTLY THROUGH THE STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU).
- 10. Pursuant to NRS 125B.145, this Order must be reviewed every three years, upon the request of either party, and is subject to modification or review and adjustment as provided by law.
- 11. Unless a stay of this Order is obtained from the District Court, all enforcement procedures, including but not limited to wage withholding, garnishment, liens and the interception of Federal Income tax refunds, will be undertaken upon entry of this Order.
- 12. The obligor is hereby given notice that failure to comply with the terms of this order may result in contempt proceedings. The obligor is required to inform the Court of

13. A 10% penalty may be assessed on each unpaid installment, or portion thereof, of an obligation to pay support for a child, pursuant to NRS 125B.095. If you pay your child support through income withholding and your full obligation is not met by the amount withheld by your employer, you are responsible to pay the difference between your court ordered obligation and the amount withheld by your employer directly to the state disbursement unit. If you fail to do so you will be subject to the assessment of penalties and interest. You may avoid these additional costs by making your current child support payments each month.
