TREASURER'S QUIT CLAIM DEED

Lindquist & Diana Lindquist Living Trust, GRANTEE(S);

WHEREAS, Kathy D. Fitro, appeared to be the then owner(s) of the said property and the tax thereon was duly levied to her upon the assessment roll for the year 2003; that the taxes levied against said property were unpaid and became delinquent; that a Certificate authorizing the County Treasurer, Lincoln County, State of Nevada, to hold said property remained unredeemed for a period of two (2) years thereafter, and that the Tax Receiver, Lincoln County, State of Nevada, did thereupon execute and deliver to the County Treasurer of the said County and State, a deed to said property, the same to be held in trust for the use of the County of Lincoln, State of Nevada, and;



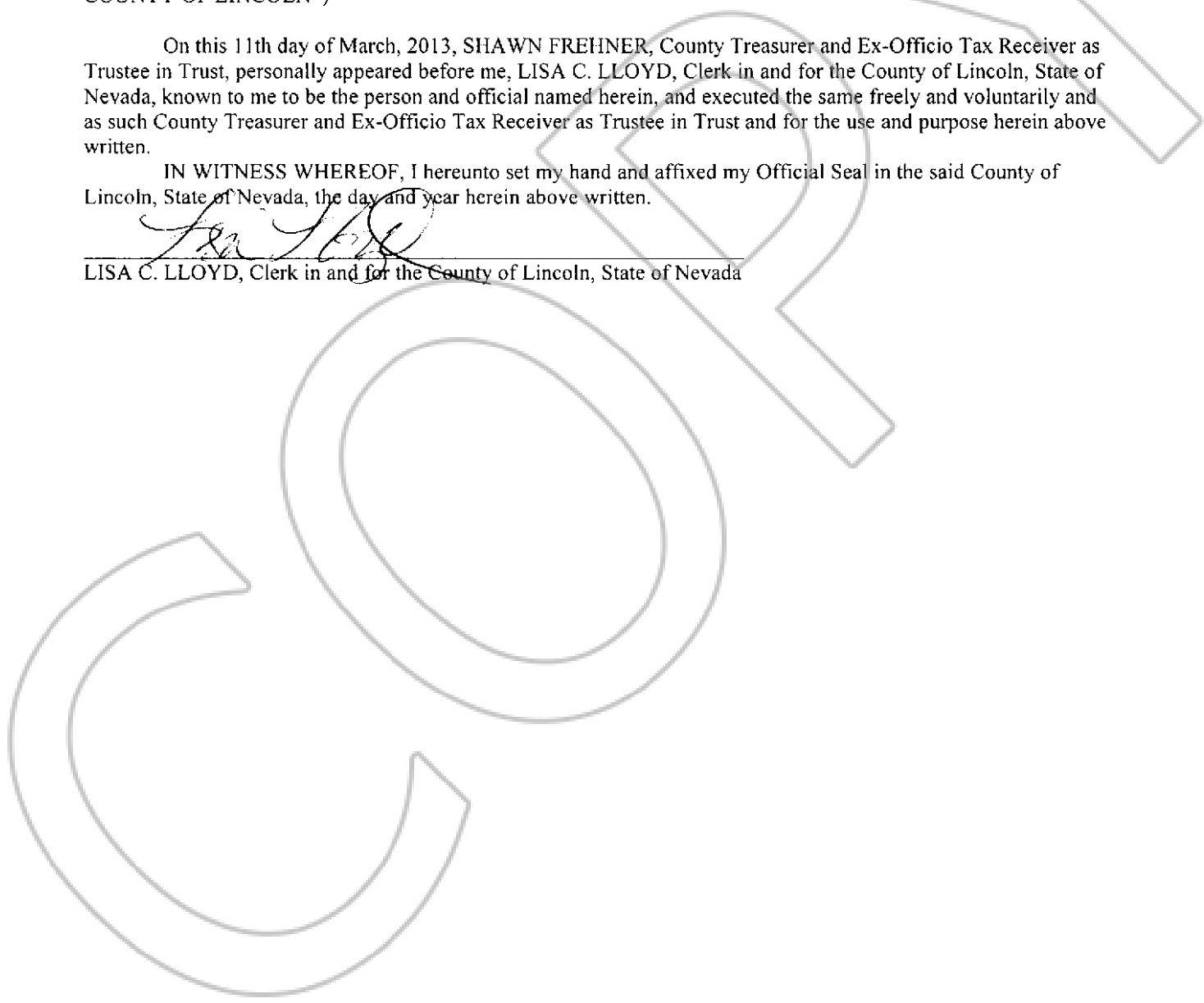
