

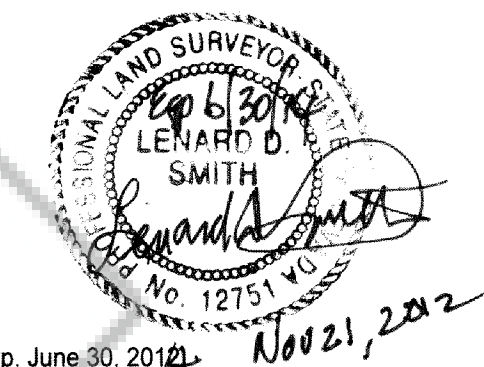

 3. The monuments depicted on the plat are of the character shown, occupy the positions indicated, and are of sufficient number and durability.

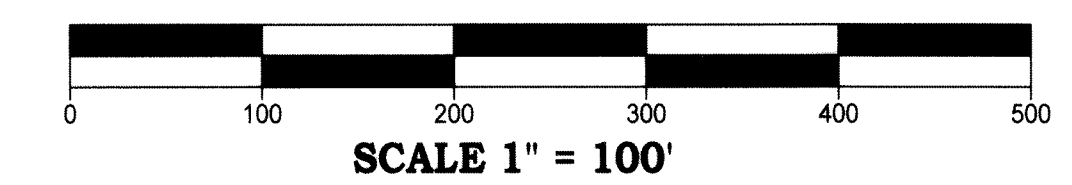

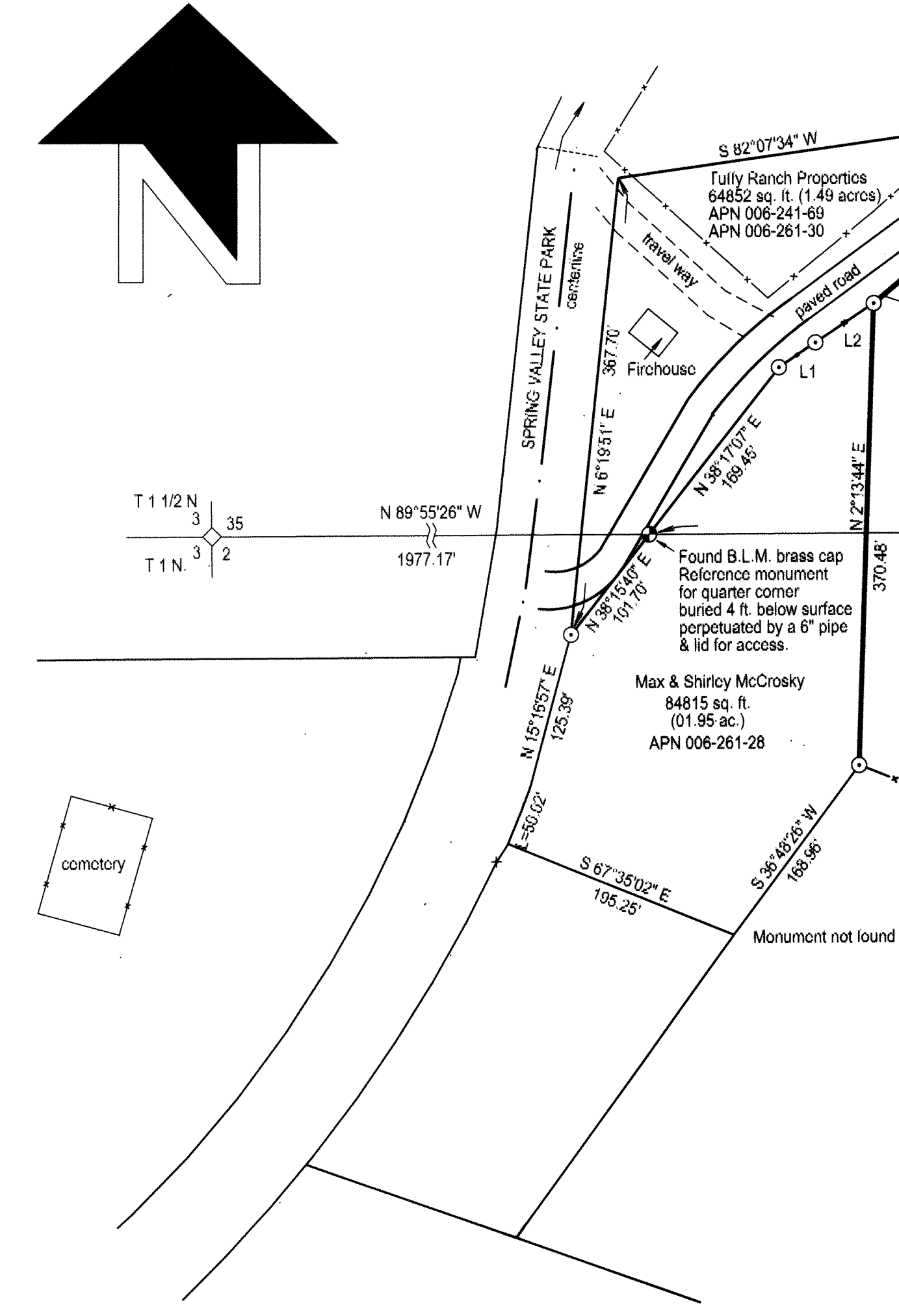
