The Discovery Monument is located SOUTH 66 DEGREES 17 MINUTES 43 SECONDS WEST, A DISTANCE OF 16,632 SFEET From the following natural/permanent monument: LOCATED AT THE NW CORNER OF SECTION 26 T9N R65E

The claim is approximately 1500 feet long and 600 feet wide, such that 300 feet are claimed in a NORTH direction and 1200 feet in a SOUTH direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the SOUTH to the NORTH direction.
