MODIFICATION TO DEED OF TRUST AND SECURITY AGREEMENT

THIS AGREEMENT is made as of the *19th* day of *September 2013*, by and between *Aaron R Egbert and Robin C Egbert, husband and wife as Joint Tenants with rights of survivorship* (herein "Borrower"), First American Title (herein "Trustee") and Pahrnagat Valley FCU, as beneficiary (herein "Lender").

WITNESSETH:

WHEREAS, on *December 24, 2012*, Trusor did make, execute and deliver to Beneficiary, that certain Deed of Trust and Security Agreement and recorded on *December 26, 2012*, as *Document No. 0142407* Official Records of Lincoln County, Nevada (the "Deed of Trust"), encumbering certain real property situate in such county and state, which Deed of Trust secures, among other obligations, payment of that certain Promissory Note Secured By Deed of Trust (the "Note") dated *December 24, 2012*, in the original principal amount of *\$38,400.00*, made by Trusor, payable to the order of Beneficiary.

WHEREAS, the parties have concurrently herewith amended the Note and desire to modify the Deed of Trust as hereinafter set forth;

NOW, THEREFORE, for a value received, the parties agree as follows:

1. Any capitalized words or terms used but not otherwise defined herein shall have the meaning given to such words or terms in the Note or the Deed of Trust.





2. The term of the loan covered under this Deed of Trust Modification *has been increased to 150 months from the date of this new modification.*
3. The original principal amount of the Deed Of Trust of *\$38,400.00 has been increased to \$115,000.00*
4. *The original note on the system has been changed from L2 to L5 and all original documents with L2 will stay in force with the understanding that the new note number is L5.*
5. *The original Deed included 3 mobile homes. This modification will only include a 1973 Fleetwood serial number S0501 and 2006 CMH/Golden West serial number PER033964CAAB.*
6. Any reference in the Deed of Trust to the "Note" shall mean the Note as amended by the Amendment To Promissory Note Secured By Deed of Trust of even date herewith.
7. Except as herein modified, the Deed of Trust remains in Full force and effect.

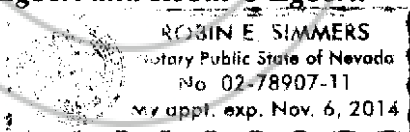


