16 The Court, having reviewed the Master's Recommendation prepared by the Court Master  
17 on May 19<sup>th</sup>, 2014, and,

- 18 (x) No timely objection having been filed hereto.
- 19 ( ) The Court, having received the objection(s) thereto, as well as any other papers,  
20 testimony and argument related thereto, and good cause appearing.

21 **IT IS HEREBY ORDERED that the Master's Findings and Recommendations are affirmed  
and adopted.**

22 **IT IS THEREFORE ORDERED AS FOLLOWS:**

24 1. (x) The Obligor is the father of the following child:

<u>NAME</u>	<u>D.O.B.</u>
Braydn Wayne Willden	October 14, 2009

27 2. (x) A Judgment is entered against Obligor for child support arrears in the amount of  
\$1,469.01 from December 1, 2013 through April 30, 2014. This shall be paid at

1 \$50.00 a month starting May 1, 2014 until paid in full. A Judgment is entered  
2 against Obligor for interest on child support arrears in the amount of \$0.00 from  
3 December 1, 2013 through April 30, 2014. A Judgment is entered against Obligor  
4 for penalties on child support arrears in the amount of \$0.00 from December 1,  
5 2013 through April 30, 2014.

6 3. (x) The Obligor shall pay \$76.00 for paternity testing. This shall be paid at \$5.00 per  
7 month starting May 1, 2014 until paid in full.

8 4. (x) The Obligor shall pay \$257.40 per month in ongoing support beginning May 1,  
9 2014 and on the same day each month thereafter until further order of this Court.

10 5. (x) The Obligor shall pay \$0.00 per month in ongoing medical cash support beginning  
11 May 1, 2014 and on the same day each month thereafter until further order of this  
12 Court.

13 **All payments MUST be in the form of a cashier's check or money order ONLY. Effective**  
14 **August 1, 2000, all child support payments must be payable to State Collection and**  
15 **Disbursement Unit (SCaDU) and mailed to: SCaDU, P.O. Box 98950, Las Vegas, NV 89193-**  
16 **8950.**

17 **NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY**  
18 **TO THE OBLIGEE OR THE CHILD.**

19 **Additionally, the Obligor MUST place his/her social security number on each payment.**

20 **Effective January 1, 2004, simple interest will accrue on all unpaid child support balances**  
21 **for cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a**  
22 **judgment of the court prior to January 1, 2004 will be enforced.**

23 **A 10% penalty will be assessed on each unpaid installment, or portion thereof, of an**  
24 **obligation to pay support for a child, pursuant to NRS 125B.095.**

25 **If you pay your child support through income withholding and your full obligation is not**  
26 **met by the amount withheld by your employer, you are responsible to pay the difference**  
27 **between your court ordered obligation and the amount withheld by your employer directly**  
28 **to the state disbursement unit. If you fail to do so you will be subject to the assessment of**  
**penalties and interest.**

**YOU MAY AVOID THESE ADDITIONAL COSTS BY MAKING YOUR CURRENT**  
**CHILD SUPPORT PAYMENTS EACH MONTH.**

6. (x) The Obligor or Obligee shall provide health insurance, including medical, dental,  
orthodontic and ophthalmological coverage for the child if available through  
his/her employment at a reasonable cost, including any group health plan(s) under  
ERISA, from the date of this order on and until said child are no longer eligible for

1 said coverage, and both parties shall cooperate and provide assistance in obtaining  
2 payment for health care services. You are required to notify the Child Support  
3 Enforcement Office when health insurance coverage is available or has been  
4 terminated.

5 Last known mailing address of child: Confidential

6 7. (x) The Obligor shall pay health care expenses, including medical, dental, orthodontic,  
7 and ophthalmological services for the child as follows: one half of all costs not  
8 covered by insurance, upon being provided by Obligee with adequate  
9 documentation/billing regarding said expenses and any EOB or other insurance  
10 payment documentation.

11 8. (x) The Obligor shall notify the State Child Support Office or the District Attorney's  
12 Child Support Office of any change of address or employment within ten (10) days.

13 9. (x) A wage/income withholding shall be issued starting immediately.


14 10. Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject  
15 to future modifications.

16 11. Unless a stay of this Order is obtained from District Court, all enforcement procedures  
17 including, but not limited to wage withholding, garnishment, liens and the attachment of  
18 federal income tax returns will be undertaken upon entry of this Order.

19 12. If any determination of paternity in this Order is at variance with the child's birth  
20 certificate issued in this state, a new birth certificate is to be issued pursuant to NRS  
21 440.325. Therefore, pursuant to NRS 126.161 Braydn Wayne Willden's birth certificate  
22 shall be amended to add Dylan Craig Day as Braydn Wayne Willden's father.

23 13. The parties shall fill out the attached Court Information Sheet and mail or deliver the same  
24 to the Nevada State Division of Welfare and Supportive Services; Child Support  
25 Enforcement Program; 1470 College Parkway, Carson City, Nevada 89706-7924 for filing  
26 with the court within ten (10) days from the date of this order. The parties shall update this  
27 form within ten (10) days of it becoming inaccurate.
