A copy of the file-stamped Articles of Organization evidencing this name change is attached to this Memorandum of Name Change.

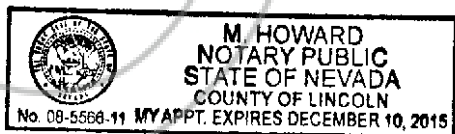
