4. The serial number assigned to each Claim and Mill Site by the Bureau of Land Management is shown on Exhibit A.



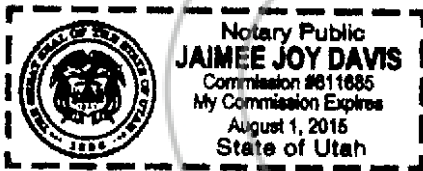
