Said locator is the proprietor or owner of the _____ (un)patented mining claims generally located in Lincoln County, Nevada.

The Mill Site is approximately 330 feet in the North direction and 600 feet in the East direction. Said Mill Site contains 5 acres, more or less. The monument of location is located as follows:

At NE corner No. 1 from which the SE corner of Section twenty-five in Township three South of Range 56 East of the Mount Diablo Meridian, bears North forty-eight degrees, twenty-one minutes, forty-nine seconds West nine hundred ninety-three and sixty-one one hundredths feet distant, thence three hundred thirty feet South zero degrees, fourteen minutes, nine seconds East to SE corner No. 2, thence six hundred sixty feet North eighty-nine degrees, twelve minutes, eight seconds West to SW corner No. 3, thence three hundred thirty feet North zero degrees, fourteen minutes, nine seconds West to NW corner No. 4, thence six hundred sixty feet South eighty-nine degrees, twelve minutes, eight seconds East to NE corner No. 1.



<u>No. 2: SE Corner</u>	<u>SE Corner - EM2</u>	<u>1 1/2" x 1 1/2" Wooden Post</u>
<u>No. 3: SW Corner</u>	<u>SW Corner - EM2</u>	<u>1 1/2" x 1 1/2" Wooden Post</u>
<u>No. 4: NW Corner</u>	<u>NW Corner - EM2</u>	<u>1 1/2" x 1 1/2" Wooden Post</u>

As erected on the ground, each corner monument is marked as described above by Paint on Posts (e.g. metal tags, paint on posts).
