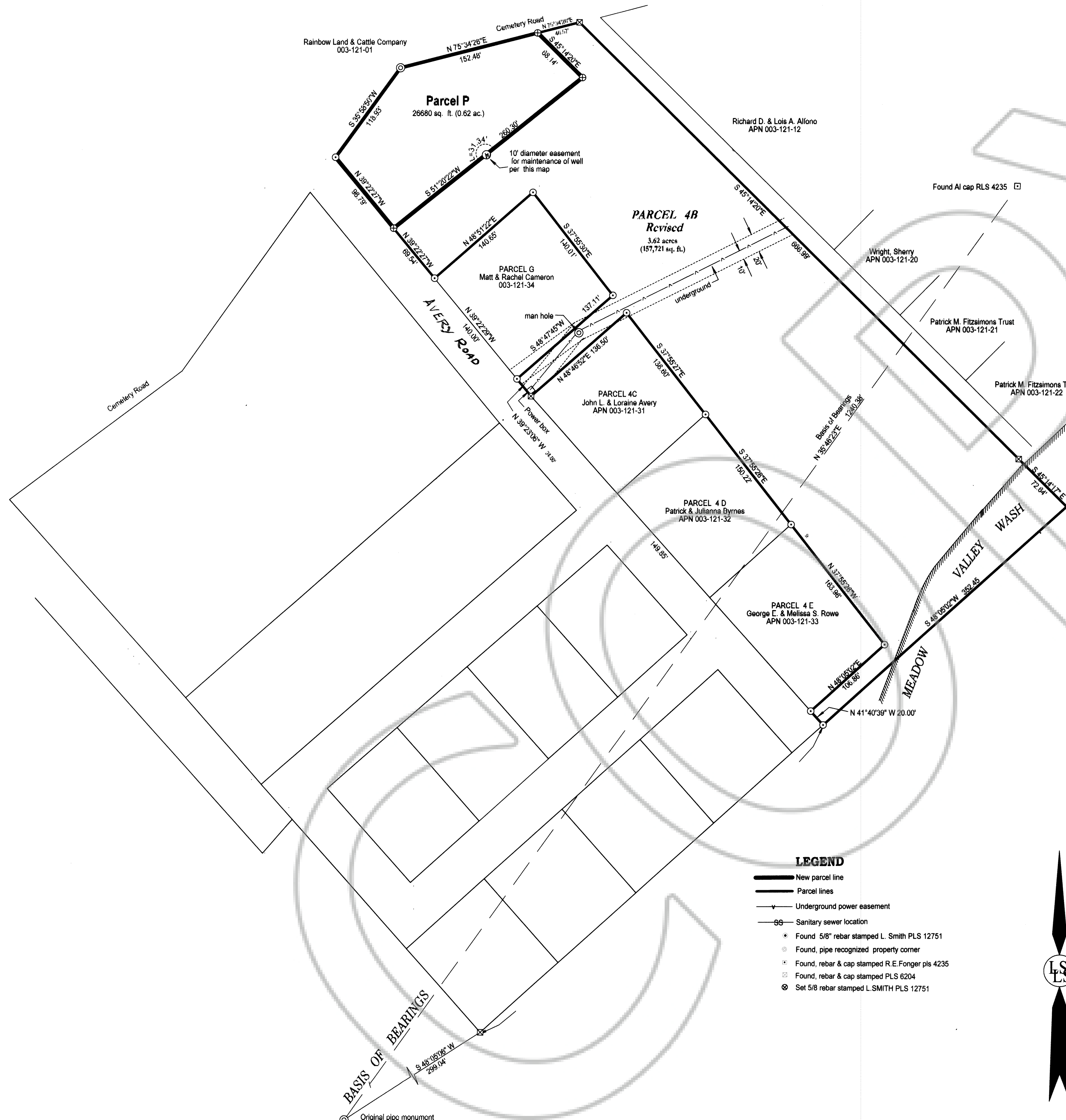


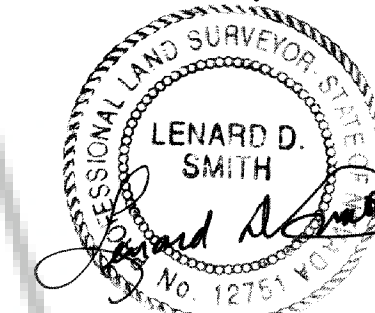
PARCEL MAP

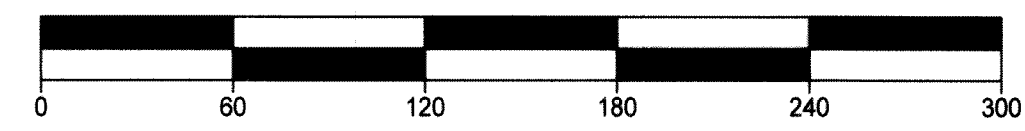
