MEMORANDUM OF AGREEMENT

THIS MEMORANDUM OF AGREEMENT ("Memorandum") is dated as of April 10, 2015, and given by WESTERN ELITE ENVIRONMENTAL INC., A Nevada corporation and BEDROC LIMITED LLC, a Nevada limited liability company (the "Landfill Entities"), in favor of COYOTE SPRINGS LAND COMPANY, LLC, a Nevada limited liability company ("CS Land") and COYOTE SPRINGS INVESTMENT LLC, a Nevada limited liability company (when taken together, the "Coyote-Companies").

Whereas the Landfill Entities and the Coyote-Companies entered into that certain "Landfill Settlement Agreement" dated April 10, 2015 (the "Agreement");

Whereas the Agreement provides that certain of Landfill Entities obligations run and burden the land owned by the Landfill Entities.

NOW THEREFORE, Landfill Entities and their respective successors and assigns agree that this Memorandum shall encumber and run with the land owned by the Landfill Entities commonly known as Lincoln County Assessor Parcel Numbers 8-201-11, and 8-201-12, and 8-201-13 for the benefit of the Coyote-Companies, which includes all of the terms, conditions, and obligations set forth in the Agreement, including, without limitation, the following:

- a. Payment by Landfill Entities to CS Land of the following: Coyote Springs exclusivity fee (Section 4(d) of the Agreement); "Franchise Royalty" (Section 4(e) of the Agreement), and "Host Fee" (Section 5 of the Agreement) pursuant to the terms set forth in the respective Sections of the Agreement;
- A discount for Coyote-Companies and certain of their affiliates for hauling industrial sold waste and/or construction – demolition debris to any "Class III Landfill" operated by Landfill Entities; and
- c. Landfill Entities grant of a Right of First Refusal in favor of, and for the benefit of, CS Land; and
- d. Any other terms, conditions, or obligations set forth in the Agreement.

This Memorandum shall expire and be of no further force or effect on the last date on which any of the Landfill Entities or their successors or assigns have completed all statutory or regulatory closure obligations for landfill operations, as required by the federal government, state government, county government or any other regulatory agency or entity.
