Containing 0.19 Acres of land more or less.

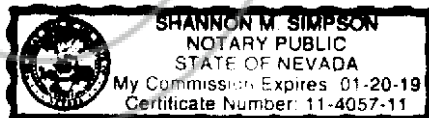
