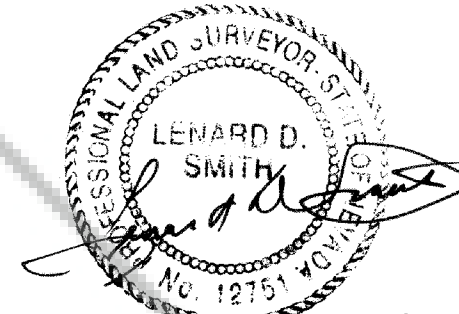

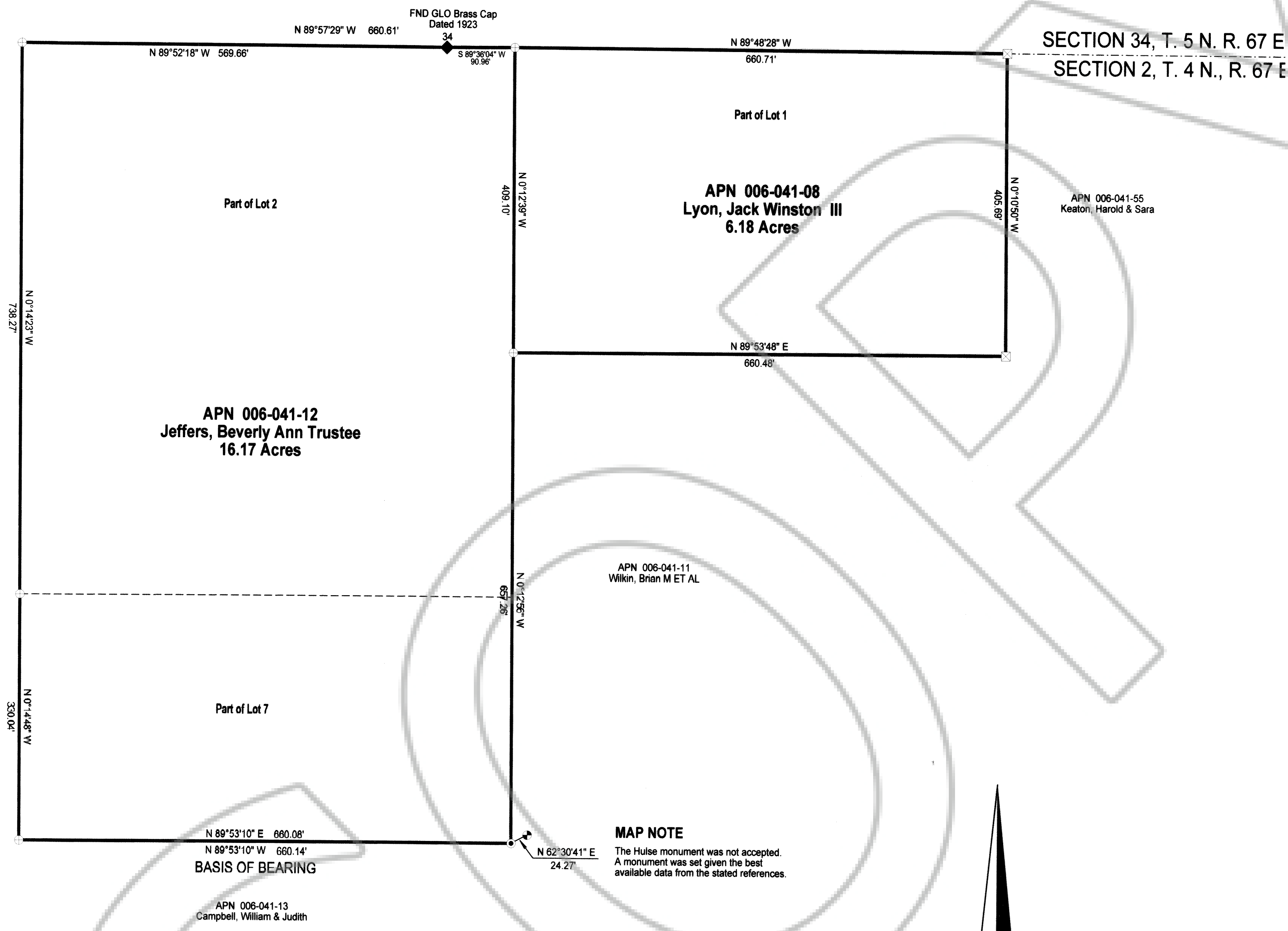

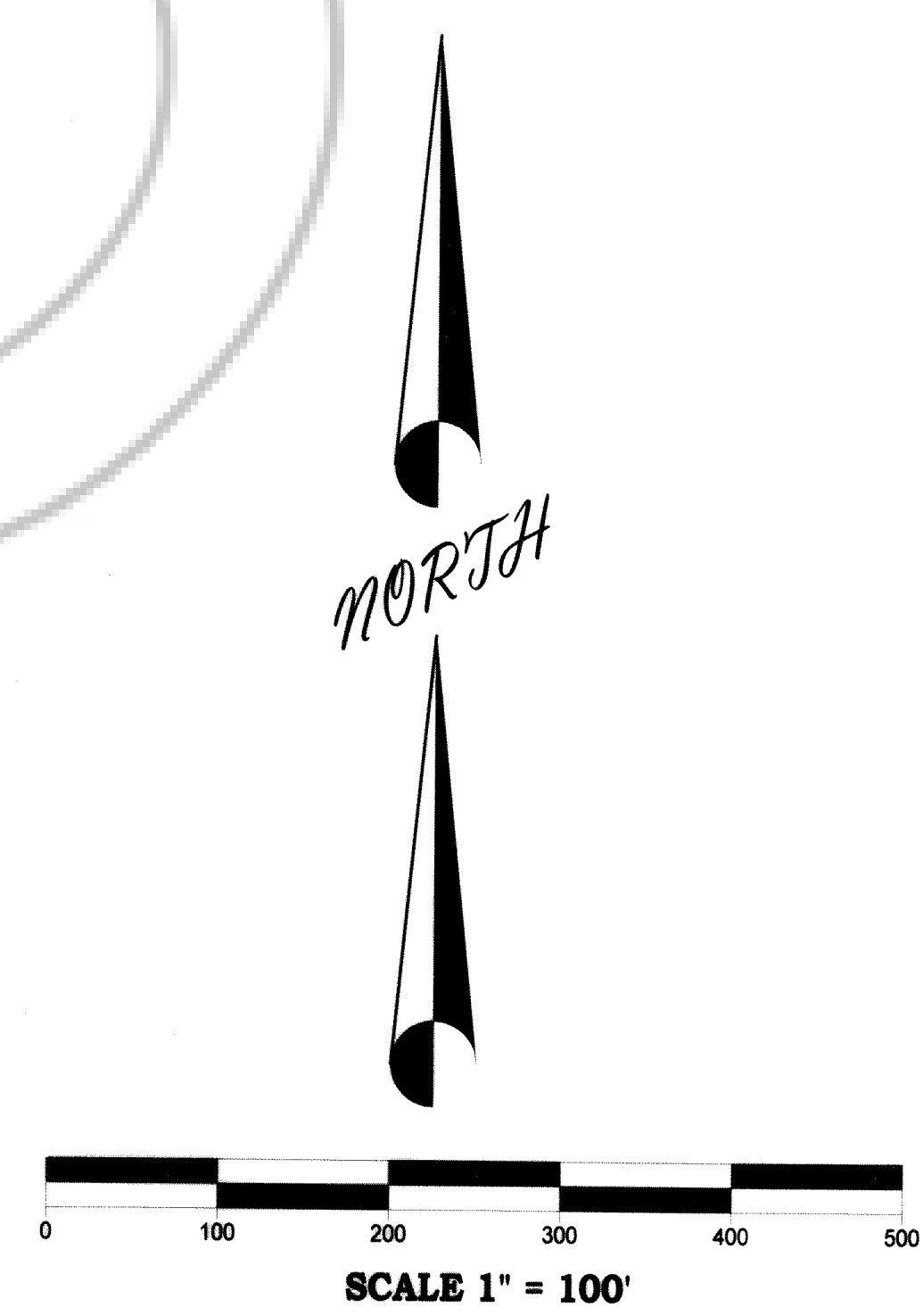
MAP NOTE:
