FOR VALUE RECEIVED, the undersigned, RONALD JEREMY ROBINSON and HOLLY LYTLE ROBINSON, husband and wife, as joint tenants with full right of survivorship, hereby promise to pay to the order of VAUGHN KAY PHILLIPS and DONNA MAE PHILLIPS, TRUSTEES OF THE VAUGHN KAY PHILLIPS AND DONNA MAE PHILLIPS FAMILY LIVING TRUST DATED THE 14th DAY OF JULY 1995, the sum of ONE HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED SIXTY ONE DOLLARS and TWENTY SEVEN CENTS (\$149,861.27), together with interest from October 1st, 2015, on the unpaid principal at the rate of 5.000% per annum; principal and interest payable in installments of NINE HUNDRED EIGHT NINE DOLLARS AND TWO CENTS (\$989.02) or more, on the 1st day of each month, beginning October, 2015, with a like payment on the same day of each month, and continuing until said principal and interest have been paid in full. Such payment shall be applied first to the payment of accrued interest and secondly to reduce the principal balance. The undersigned may pay an amount in excess of the monthly payment provided they are not in default.

The undersigned shall be reserved the privilege to prepay this Note in whole or in part at any time without penalty.

In the event all or any part of the property secured by the Deed of Trust of even date herewith be sold, conveyed, transferred, or exchanged, then the Note secured hereby shall become immediately due and payable at the option of the holder of said Note.

The undersigned promise and agree that in case of default in the payment of any installment of principal and/or interest as provided herein or in case of failure to perform any covenant in the Deed of Trust securing this Note, or in the event of failure to pay any installment of principal and/or interest in accordance with the terms of any note secured by a Deed of Trust having priority over the Deed of Trust securing this Note, or in the event of failure to perform any covenant contained in said prior Deed of Trust to be performed by the Trustor named therein, or in the event that any maker of this Note shall make a general assignment for the benefit of creditors or be adjudged a bankrupt, then upon the happening of any one of such events the whole sum of principal and interest which shall then remain unpaid shall become forthwith due and payable although the time of maturity as expressed in this Promissory Note shall not have arrived.

3 expenses in connection therewith including a reasonable attorney's fee.

5 unenforceable in any respect, such provision shall be deemed to be severed from the Note, and
6 the validity, legality and enforceability of the remaining provisions contained herein shall not in
7 any way be affected or impaired thereby. Without limiting the generality of the foregoing, any
8 provisions herein to the contrary notwithstanding, holder shall in no event be entitled to receive or
9 collect, nor shall or may amounts received hereunder be credited, so that holder shall be paid, as
