JUDGMENT

This matter came on regularly for trial on August 4, 2015, before the Honorable Jennifer Klapper, Justice of the Peace. After hearing the testimony, reviewing the evidence and considering the same, the court finds in favor of the Plaintiff and against the Defendant.

IT IS HEREBY ORDERED that the defendant, BENJAMIN SPERRY, pay the plaintiff, RICHARD and PATRICIA RANDOLPH, the sum of \$4,715.87, plus court cost of \$126.00, for a total of \$4,841.87. If Defendant returns the blue antique mirror to the Plaintiff by August 6, 2015, the amount of \$515.87 will be deducted from the total. Judgment shall be paid in full within 30 days (by September 4, 2015).
