The Discovery Monument is located SOUTH 65° 8 Minutes 24 Seconds EAST, A Distance of 10,866 feet

The claim is approximately 1500 feet long and 600 feet wide, such that 600 feet are claimed in a SW  
direction and 900 feet in a NE direction from the point of discovery (monument of location), at which  
the Notice of Location was posted, together with 300 feet on each side of the monument of location and  
center line of the Claim. The general course of the lode or vein is from the SW to the NE direction.
