DEFINITIONS

(A) "Security Instrument" means this document, which is dated August 15, 2016, together with all Riders to this document.

(B) "Borrower" is CHARLES P. MASTERS AND FLORENCE MASTERS, HUSBAND AND WIFE, AS JOINT TENANTS WITH RIGHT OF SURVIVORSHIP. Borrower is the trustor under this Security Instrument.



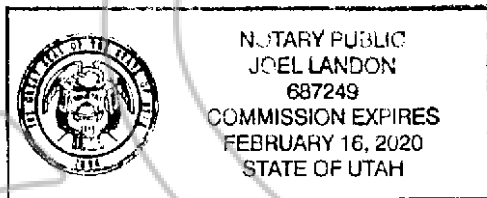


