- 1. I have personal knowledge of the following facts.
- 2. I have reviewed the Title Report, Order Number 77773, from Cow County Title dated January 26, 2017 (the "Title Report").
- 3. Exception numbered 16 in the Title Report relates to a Lease dated May 12, 1993 between Bradshaw, Inc. and Fargo Pacific Aggregiate Co., Inc. (the "Lease")
- 4. I have searched the files of Bradshaw, Inc. and I have not been able to locate a copy of the Lease.
- 5. I have searched the Nevada Secretary of State's website and found that Fargo Pacific Aggregiate Co., Inc. dissolved and abandoned its corporate charter in 2002. A copy of the Nevada Secretary of State website page for Fargo Pacific Aggregiate Co., Inc. is attached hereto as Exhibit "A".
- 6. I spoke on the telephone on March 13, 2017 with Jerald K. Grantham, the last Secretary for Fargo Pacific Aggregiate Co., Inc.
- 7. Jerald K. Grantham informed me that the last President and Treasurer of Fargo Pacific Aggregiate Co., Inc., Mr. Grover Bynum, is deceased.
- 8. Jerald K. Grantham informed me that any efforts that Fargo Pacific Aggregiate Co., Inc. had with respect to the Lease ended "100 years ago".
- 9. I recall my uncle Don Bradshaw telling me 20 plus years ago that he was going to do business with a gravel company out of Las Vegas.

- 10. I am a shareholder of Bradshaw, Inc. I have visited the Lease site multiple times each year for the past 20 years.
- 11. Based on my personal knowledge, there has been no activity in the Lease site in the past 20 years.
- 12. Based on my personal knowledge, no persons or entities, including Fargo Pacific Aggregiate Co., Inc., has paid any lease payments, royalties or other consideration for any lease or use of the Lease site in 20 years.
- 13. I have confirmed both of the above representations in paragraphs 11 and 12 with my Bradshaw relatives in Lincoln County, some of whom have visited and/or worked the neighboring ranch weekly for the past 20 years.
- 14. On behalf of Bradshaw Inc., I hereby state that the Lease was terminated many years ago due to non-performance and should be considered void in all matters.
