All that certain real property situate in the County of Lincoln, State of Nevada, described as follows:





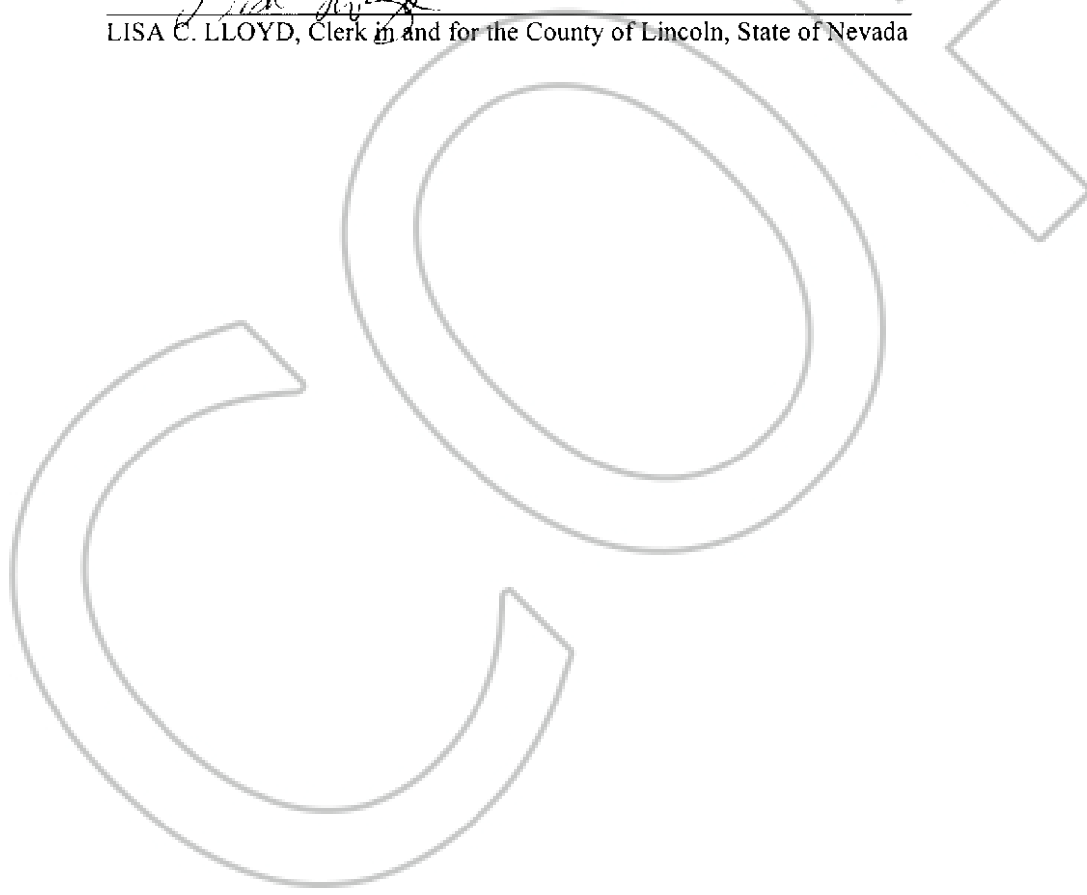
