DEFAULT JUDGMENT AND ORDER

The Court Master, having found that the Respondent was properly served on June 15, 2005 and having found that the Respondent has failed to respond as required by law, finds as follows:

Petitioner has named the Respondent as the parent of the following children:

Income is \$1646.67 based on verified wages; formula amount for child support is 18% which equals \$ 296.00 per month.

1 Respondent is to pay monthly:  
2 \$296.00 child support  
3 \$ medical support (payment in lieu of health insurance)  
4 \$ spousal support  
5 \$30.00 arrears payment to be applied to:

6 child support arrearages of \$29555.00  
7 medical support arrearages of \$  
8 spousal support arrearages of \$  
9 medical expenses arrearages of \$  
10 genetic test costs of \$  
11 total arrearages of \$29555.00

12 Arrears were accrued from April 01, 2001 through July 31, 2005.

13 The total arrears are reduced to judgment. Interest will be assessed on all unpaid child support  
14 balances for cases with a Nevada controlling order pursuant to NRS 99.040. A 10% penalty will be  
15 assessed on each unpaid installment, or portion thereof, of an obligation to pay support for a child,  
16 pursuant to NRS 125B.095.

17  The Respondent shall provide health insurance coverage for the minor child(ren) herein  
18  if available through employer.

19  The Respondent shall provide proof of said insurance and 5 claim form(s) to the District  
20 Attorney's Family Support Division within 90 days of today's date.

21 The Respondent shall pay \$326.00 total monthly payment. \$326.00 to be paid on or before  
22 the 30th of each month, and with the next payment due August 30, 2005 and continuing thereafter until  
23 said child(ren) reach majority, become emancipated or further order of the court.

24 It is hereby ordered, adjudged and decreed that an income withholding shall be instituted  
25 immediately pursuant to NRS 31A.025 through NRS 31A.350.

26  It is further ordered that: This is an NRS425 case; therefore no further court date is necessary at  
27 this time.

28 If the Respondent pays support through income withholding and the full obligation is not met by  
the amount withheld by the employer, the Respondent is responsible to pay the difference between the  
court ordered obligation and the amount withheld by the employer directly to the state disbursement  
unit. If the Respondent fails to do so, he/she may be subject to assessment of penalties and interest. The  
Respondent may avoid these additional costs by making current support payments each month.

1 It is hereby ordered, adjudged and decreed that all property is subject to actions for collection  
2 including, but not limited to, withholding of wages, garnishment, liens, and the attachment of federal  
3 income tax returns.

4 It is hereby ordered, adjudged and decreed that all payments made by mail must be made in the  
5 form of cashier's check, money order or business check only, made payable to and sent to:

7 State Collection and Disbursement Unit (SCaDU)  
8 P.O. Box 98950  
9 Las Vegas, Nevada 89193-8950.

10 Payments may also be made in person at State Collection and Disbursement Unit, 3120 E. Desert  
11 Inn Road, Las Vegas, Nevada, in the exact amount of cash, cashier's check, money order or business  
12 check. The following information must be included with each payment: name (first, middle, last) of  
13 person responsible for paying support, social security number of person responsible for paying support,  
14 case number, and name of custodian (first and last name of person receiving support). No credit will be  
15 given for payments paid directly to the Petitioner.

16 Pursuant to NRS 125B.145 this order may be reviewed every three years and is subject to future  
17 modification.
