MEMORANDUM OF LICENSE SUPPLEMENT

WHEREAS, Licensor is the owner of certain real property located at 167 Main Street, Caliente, Lincoln County, Nevada, which is more particularly described in <u>Exhibit A</u>, attached hereto and incorporated herein by reference (the "Property"), together with a building (the "Building") and a wireless telecommunications tower (the "Tower") located on the Property; and

WHEREAS, pursuant to a License Supplement of even date herewith (the "Supplement"), which Supplement is governed by a Master Tower License Agreement of even date herewith, Licensor has granted Licensee a license to install, operate, use, and maintain communications equipment within certain space within the Building and on the Tower; and

WHEREAS, Licensor and Licensee desire to file this Memorandum of record in the Office of the County Recorder for Lincoln County, Nevada, in order to provide record notice to third parties of Licensee's license related to a portion of the Property;

NOW, THEREFORE, for and in consideration of the premises, and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are expressly

acknowledged by the parties, Licensor and Licensee agree and acknowledge for themselves and their respective successors and assigns, as follows:

- 1. Licensor has granted Licensee a license to install, operate, use, and maintain communications equipment within certain space within the Building and on the Tower, which space is more specifically described in the Supplement.
- 2. The term of the Supplement is ten (10) years commencing on the Commencement Date as set forth in the Supplement. Licensee may extend the term of the Supplement for four (4) renewal terms of five (5) years each, upon the terms and conditions set forth in the Supplement.
- The Supplement is binding upon Licensor and Licensee, and their respective successors and assigns.
- 4. This Memorandum contains only selected provisions of the Supplement, and reference is made to the full text of the Supplement for all of the applicable terms and conditions. This Memorandum does not, in any way, amend or supersede the terms and conditions of the Supplement.
- 5. This Supplement may be executed in two or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.


