TREASURER'S RECONVEYANCE DEED

A reconveyance may not be made after expiration of the 90-day period specified in NRS 361.603", and

WHEREAS, to Andra Farmer Trustee, has tendered to the County Treasurer, on August 10, 2017, the proper amount of money as is required in such cases.
