**PARCEL ONE:**

A parcel of land situated in the Southwest quarter of the Southwest quarter of Section 9, Township 2 South, Range 68 East, M.D.M being more particularly described as follows:

Beginning at the Northwest corner of said parcel from which the Southwest corner of said Section 9 bears South 47°00'48" West, a distance of 1,540.00 feet; Thence East a distance of 63.00 feet to the Northwest corner; Thence South, 0°28' 45" East, a distance of 95.66 feet to the Southeast corner; Thence South 77°45'18" West, a distance of 63.09 feet to the Southwest corner; Thence North 1°07'45" West a distance of 109.04 feet more or less to the Northwest corner which is the point of beginning.
