1 2 (x) A Judgment is entered against Obligor for child support arrears in the amount of
2 \$24,720 99 from June 1, 2011 through July 31, 2018 This shall be paid at \$500 00
3 a month starting August 1, 2018 until paid in full A Judgment is entered against
4 Obligor for interest on child support arrears in the amount of \$6,957 99 from June
5 1, 2011 through July 31, 2018 A Judgment is entered against Obligor for penalties
6 on child support arrears in the amount of \$2 544 32 from June 1, 2011 through July
7 31, 2018

8 3 (x) The Obligor shall pay \$504 48 per month in ongoing support beginning August 1,
9 2018 and on the same day each month thereafter until further order of this Court

10 4 (x) The Obligor shall pay \$0 00 per month in ongoing medical cash support beginning
11 August 1, 2018 and on the same day each month thereafter until further order of
12 this Court

13 **All payments MUST be in the form of a cashier's check or money order ONLY Effective**
14 **August 1, 2000, all child support payments must be payable to State Collection and**
15 **Disbursement Unit (SCaDU) and mailed to SCaDU, P.O Box 98950, Las Vegas, NV 89193-**

17 **NOTICE NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY**
18 **TO THE OBLIGEE OR THE CHILDREN**

19 **Additionally, the Obligor MUST place her social security number on each payment**

20 **Effective January 1, 2004, simple interest will accrue on all unpaid child support balances**
21 **for cases with a Nevada controlling order pursuant to NRS 99 040 Interest assessed by a**
22 **judgment of the court prior to January 1, 2004 will be enforced**

23 **A 10% penalty will be assessed on each unpaid installment, or portion thereof, of an**
24 **obligation to pay support for a child, pursuant to NRS 125B 095**

25 **If you pay your child support through income withholding and your full obligation is not**
26 **met by the amount withheld by your employer, you are responsible to pay the difference**
27 **between your court ordered obligation and the amount withheld by your employer directly**
28 **to the state disbursement unit If you fail to do so you will be subject to the assessment of**
penalties and interest

1 (x) The Obligee shall provide health insurance, including medical, dental, orthodontic
2 and ophthalmological coverage for the children if available through her
3 employment at a reasonable cost, including any group health plan(s) under ERISA,
4 from the date of this order on and until said children are no longer eligible for said
5 coverage, and both parties shall cooperate and provide assistance in obtaining
6 payment for health care services You are required to notify the Child Support

1 Enforcement Office when health insurance coverage is available or has been
2 terminated

3 Last known mailing address of Obligor Confidential

4 Last known mailing address of children Confidential

5 6 (x) Any medical, dental, optical, orthodontic, or any other health-related expense
6 incurred for the benefit of the minor children that is not covered by insurance,
7 including deductibles, co-pays, or other un-reimbursed expenses, shall be equally
8 divided between the parties. The party incurring the cost shall have thirty (30) days
9 to provide documentation of the expense/receipt to the other party, if not tendered
10 within the thirty (30) day period, the Court may consider it as a waiver of
11 reimbursement. At which time the other party shall have thirty (30) days to
12 reimburse one-half (1/2) the expense, if not paid or disputed in writing within the
13 thirty (30) day period, the party may be subject to a finding of contempt and
14 appropriate sanctions

15 7 (x) The Obligor shall notify the State Child Support Office or the District Attorney's
16 Child Support Office of any change of address or employment within ten (10) days

17 8 (x) A wage/income withholding shall be issued starting immediately


18 9 Pursuant to NRS 125B 145 this Order may be reviewed every three (3) years and is subject
19 to future modifications

20 10 Unless a stay of this Order is obtained from District Court, all enforcement procedures
21 including, but not limited to wage withholding, garnishment, liens and the attachment of
22 federal income tax returns will be undertaken upon entry of this Order

23 11 If any determination of paternity in this Order is at variance with the children's birth
24 certificate issued in this state, a new birth certificate is to be issued pursuant to NRS
25 440 325

26 12 The parties shall fill out the attached Court Information Sheet and mail or deliver the same
27 to the Nevada State Division of Welfare and Supportive Services, Child Support
28 Enforcement Program, 1470 College Parkway, Carson City, Nevada 89706-7924 for filing
with the court within ten (10) days from the date of this order. The parties shall update this
form within ten (10) days of it becoming inaccurate.
