





This matter having come before the Court on Plaintiff's Complaint for damages and other relief ("Complaint"), and the Court having considered the Motion for Entry of Default Judgment as to the Defendant, the attachments thereto, and being fully advised in the premises, makes the following findings and enters the following judgment:

- 1. The Court finds that the Defendants were properly served with the Complaint and Summons and are in default for failing to answer or respond within the required time.
- 2. Venue is proper pursuant to Colorado Rules of Civil Procedure (C.R.C.P.) Rule 98.
- 3. The Defendant is not a minor, incompetent or incapacitated, an officer or agent of the State of Colorado, or in the military service.
- 4. The Court finds that the monetary damages and interest have been sufficiently proven and documented by the Plaintiff.
- 5. The Court finds that the Defendant agreed to pay attorneys' fees and collection costs in the Professional Services Agreement signed between the Parties, that the Plaintiff did incur attorneys' fees and collection costs, and that the amount requested by the Plaintiff is reasonable.

- 4. The allegations against the Defendant contained in the Complaint are deemed admitted.
- 5. There being no responsive pleading filed by the Defendants in this matter, and upon review of the Complaint, the Motion for Entry of Default Judgment as to the Defendant and Affidavits attached thereto, the remedies sought by Plaintiff in this matter are provided by law, and sufficient evidence exists for the entry of relief in this matter as requested by the Plaintiff.
- 6. Judgment by default has been sought by the Plaintiff against the Defendant, and the relief sought is intended to be the obligation of the Defendant. There is no just reason to delay entering judgment against the Defendant. Therefore, the Court finds that the Plaintiff is entitled to monetary damages.


## THEREFORE, IT IS HEREBY ORDERED as follows:

- 1. The Court has jurisdiction over the Defendant and the subject matter of this action.
- 2. The Court hereby enters judgment in favor of Plaintiff Gustavson Associates, LLC, and against Defendant, International Silver, Inc., in the amount of \$78,240.28. This amount reflects the principal of \$48,176.20 and interest of \$24,636.43 on the debt owed by Defendant to Plaintiff. The amount also includes attorney's fees of \$5,168.75 and court costs, process service fees and expenses of \$258.90. The judgment will bear interest at the rate of 1.5 percent per month until satisfied, and constitute a final judgment in favor of the Plaintiff and against the Defendant, as of the date of this judgment. The clerk shall enter the judgment in the Register of Actions and Judgment Record pursuant to C.R.C.P. 79(a) and 79(d).
