The Claim is approximately 1500 feet long and 600 feet wide, such that 5 feet are claimed in a N81°5'31"E direction and 1,495 feet in the opposite direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the **NORTHEAST** to the **SOUTHWEST** direction.

The Discovery Monument upon which a Notice of Location is POSTED, is situate about 6,841 feet SOUTH and 277 feet WEST from the USMM No. 326 which is located approximately 4,500 feet NORTH and 1,020 feet EAST of the SW Corner of Section 31, Township 3 South, Range 57 East, Mount Diablo Base & Meridian.
