1 2. That Casey E. Folks, Jr. (Decedent) died on or about January 12, 2017, in Clark
2 County, Nevada, where he was a resident at the date of his death. Petitioner has been serving as the
3 Personal Representative of the Decedent's Estate since his appointment by Order of this Court on
4 October 20, 2017. On November 6, 2017, Letters Testamentary were issued to Petitioner.

5 3. That Decedent had a trust entitled Revocable Living Trust Plan for Casey E. Folks,
6 Jr., dated August 25, 2004 ("Trust").

7 4. That due and legal notice to creditors of said Estate has been given in the manner and
8 for the time required by law. The time for presentation of claims expired on February 15, 2018, and
9 no claims were filed.

10 5. This Court may waive the requirement of the inventory and record of value "if all
11 interested persons agree in writing to the waiver." NRS 144.010. Waiver from the two heirs and
12 devisees of the Estate has been filed with the Court.

13 6. The Court may waive the requirement of the first and final account "if all interested
14 persons agree in writing to the waiver." NRS 150.075. Waivers of Accounting from the sole heir
15 and devisee of the Estate has been filed with the Court.

16 7. That said Estate is ready for distribution and now in a condition to be closed.

17 8. Attorney's fees and any costs of administration shall be paid from the Trust.

18 9. That under the provisions of his Last Will and Testament and his Trust, Decedent
19 devised and bequeathed his property as follows:

21 **Section 3.04. Dividing the Resulting Trust Estate Into Shares.**

22 The Trustee(s) shall thereafter divide the Trust Estate into shares for the benefit of the
23 Beneficiaries of the Creator(s) named herein. Each beneficiary shall be entitled to receive
24 a share of the Trust Estate as designated in Section 3.06(B) of this Declaration of Trust.

25 **Section 3.06(B). Distribution of the Residuary Estate.**

26 Upon the demise of the Creator, the Successor Trustee shall then distribute the remaining
27 trust property (including any lapsed gifts from above to the following Beneficiaries in the
28 following percentages (subject to Sections 1.03 and 1.04 above):

10 not limited to, partnership interests, business stocks, limited liability company ownership or
11 membership interests, rights or claims of any kind, including in C& J Investments, Inc., in which the
12 decedent held an interest in any capacity are hereby transferred and/or set aside to the Trust.

13 **IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED:**

14 A. That the Court waives Inventory of the Decedent's Estate and the First and Final
15 Account of the Personal Representative of the Decedent's Estate upon the written agreement of all
16 interested persons.

17 B. That the Personal Representative shall deliver and set over onto DARYL E. FOLKS
18 and BRYAN W. FOLKS all remaining proceeds received by the Estate consisting of real and
19 personal properties set forth in Exhibit "1" attached hereto. By way of this Order the Personal
20 Representative shall be authorized to execute such deeds of conveyance and instruments as necessary
21 to transfer the real and personal properties to the Trust for the benefit of the Beneficiaries.

22 C. That under the provisions of his Last Will and Testament and his Trust, Decedent
23 devised and bequeathed all his property not otherwise titled in the name of the Trust as follows: (i)
24 Daryl E. Folks, 50%; and (ii) Bryan W. Folks, 50%.

25 D. That after distribution by the Personal Representative of the above real and personal
26 property, and payment of said sums for attorney's fees and costs, said Estate shall be entirely
27 depleted.

28 E. That on the filing of appropriate receipts, the Petitioner be discharged from further
responsibilities as such Personal Representative, and that said Estate be then closed.

1 F. For such other and further relief as to the Court may seem meet and proper in the
2 premises.



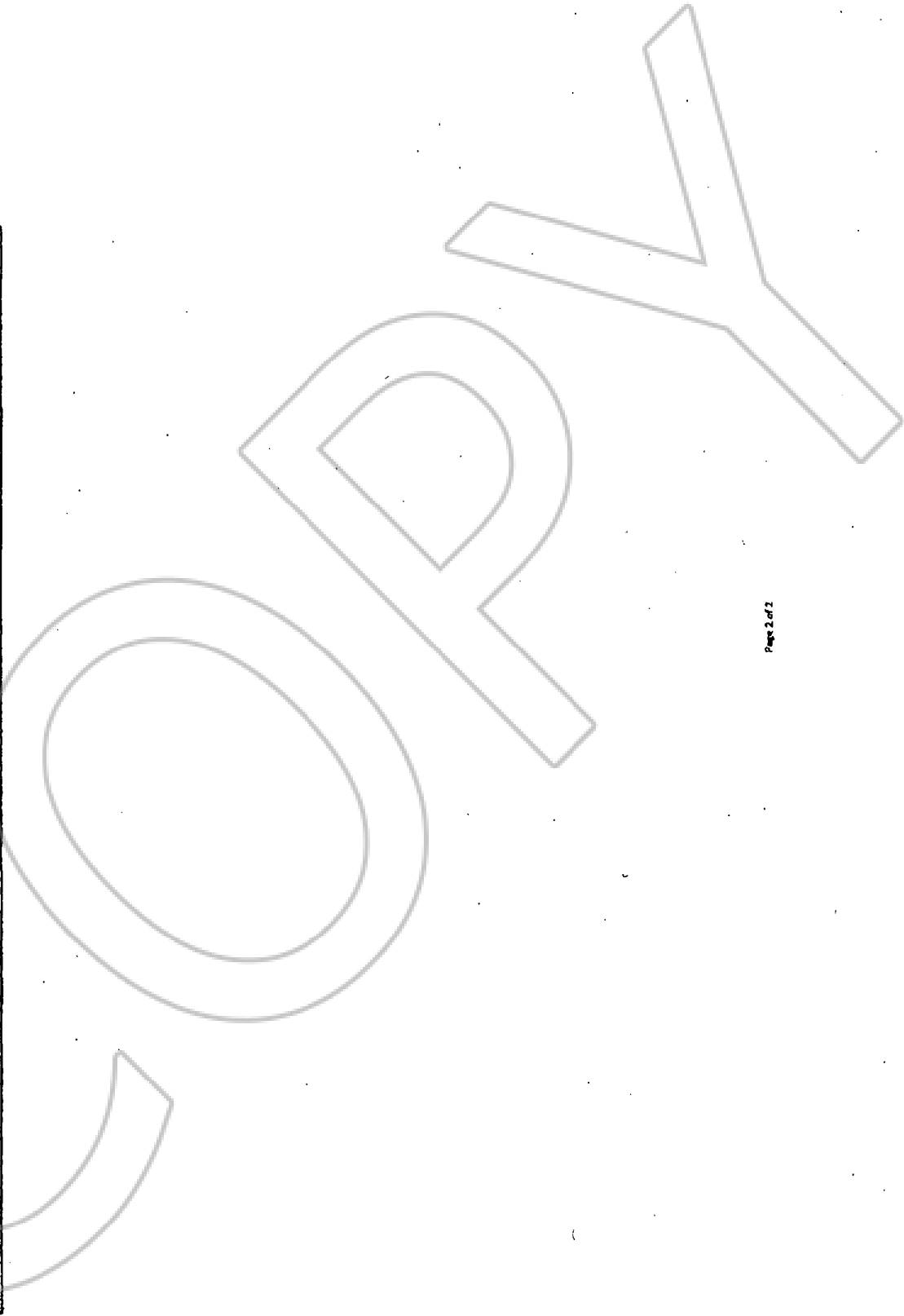
