MODIFICATION OF LINE OF CREDIT DEED OF TRUST

IT IS INTENDED THAT THIS JURY WAIVER WILL BE ENFORCED TO THE MAXIMUM EXTENT ALLOWED BY LAW.
- 2.7 Limited Liability and Waiver. The following parties join in this instrument to perfect the lien offered as security for the Secured Obligations and to acknowledge the covenants and conditions contained herein are applicable to them as owners of the described property, but assume no liability for payment of the Note(s): Branton Genco, Abigail K.
