The general course of the claim is N 62.5 E and is approximately 1,250 feet long and 600 feet wide, such that 1,230 feet are claimed in a northeast direction and 20 feet in a southwest direction from the point of discovery (monument of location), at which this Notice of Location is posted, together with 300 feet on each side of the location monument and center line of the claim.
