17 This matter having come on for hearing this 10th day of April 2017, Plaintiff,
18 MELINDA CROSTHWAIT appearing by and through her attorney, Anita A.
19 Webster, Esq., and Jeanne F. Lambertsen, Esq., of the law firm WEBSTER and
20 ASSOCIATES, Defendant VANCE CROSTHWAIT, not appearing, for an
21 Evidentiary Hearing, and the Court having considered the papers and pleadings
22 on file, and having heard the arguments of counsel and good cause appearing,
23 an award of attorneys' fees and cost is reasonable based on the Brunzell factors.
24 Pursuant to Brunzell v. Golden Gate Nat'l Bank, 85 Nev. 345 (1969), the Court
25 has taken into consideration the following factors in determining the award of
26 attorneys' fees; (1) The qualities of the advocate(s): Ms. Webster has been
27 practicing law for 32 years and Ms. Lambertsen has been practicing law for 13
28 years; the law firm's practice is dedicated to family law. (2) The character and

1 difficulty of the work performed: The intricacy, importance, time and skill required
 2 to prepare this case for the Evidentiary Hearing and present evidence and
 3 testimony at the Evidentiary Hearing is moderate too difficult. (3) The work
 4 actually performed by the attorneys: Approximately 110.90 hours were spent by
 5 counsel and 39.30 hours were spent by the paralegals as of April 24, 2017, (4)
 6 The result obtained was in favor of the Plaintiff, MELINDA.

7 The Court notes that the Plaintiff's Memorandum of Fees and Costs filed
 8 on or about April 28, 2017 states that Plaintiff's fees and costs are from the date
 9 of the Plaintiff's initial consultation on April 12, 2016 through and including the
 10 preparation of the Memorandum of Fees and Costs on April 24th, 2017. The total
 11 amount of fees and costs *includes* the \$2,252.00 awarded to the Plaintiff by the
 12 Discovery Commissioner in the order filed on March 1, 2017, and the \$885.00
 13 awarded to the Plaintiff by the Discovery Commissioner in the order filed on
 14 March 7, 2017 :
