## Judgment Re: Plaintiff's Award of Attorney Fees and Costs

This matter having come on for hearing this 10<sup>th</sup> day of April 2017, Plaintiff, MELINDA CROSTHWAIT appearing by and through her attorney, Anita A. Webster, Esq., and Jeanne F. Lambertsen, Esq., of the law firm WEBSTER and ASSOCIATES, Defendant VANCE CROSTHWAIT, not appearing, for an Evidentiary Hearing, and the Court having considered the papers and pleadings on file, and having heard the arguments of counsel and good cause appearing, an award of attorneys' fees and cost is reasonable based on the Brunzell factors. Pursuant to Brunzell v. Golden Gate Nat'l Bank, 85 Nev. 345 (1969), the Court has taken into consideration the following factors in determining the award of attorneys' fees; (1) The qualities of the advocate(s): Ms. Webster has been practicing law for 32 years and Ms. Lambertsen has been practicing law for 13 years; the law firm's practice is dedicated to family law. (2) The character and

(3) The work actually performed by the attorneys: Approximately 110.90 hours were spent by counsel and 39.30 hours were spent by the paralegals as of April 24,2017, (4) The result obtained was in favor of the Plaintiff, MELINDA.
