The claim is approximately 1500 feet long and 600 feet wide, such that 50 feet are claimed in a NORTH direction and 1450 feet in a SOUTH direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 feet on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the NORTH to the SOUTH direction.



<u>No.3: SW CORNER</u>	<u>SW CORNER #3 CULVERWELL 2</u>	<u>2" x 2" WOODEN POST</u>
<u>No.4: NW CORNER</u>	<u>NW CORNER #4 CULVERWELL 2</u>	<u>2" x 2" WOODEN POST</u>
