

Said Placer Claim contains 20 acres, more or less. The Township is unsurveyed and the subject section is non-standard being designated on the Master Title Plat (last revised June 20, 2009) and on the Nevada Protracted Diagram No. 176 (dated January 22, 1964, filed on June 14, 1965) as consisting of only 525 acres. Pursuant to BLM Nevada State Office staff guidance, typical aliquot part designations are assumed in the northern portion of the subject section (i.e., the N/2), with any potential future lots being designated in the southern portion of the subject section (i.e., the S/2).
