
Sprott Private Resources Lending II (Collector), LP ("Lender"), as Administrative Agent for the benefit of the Lenders under that certain Credit Agreement dated August 10, 2018, is the owner of that certain indebtedness described in that certain Fee and Leasehold Deed of Trust, Assignment of Royalties, Leases and Rents, Security Agreement, Fixture Filing and As-Extracted Collateral Filing dated August 10, 2018 (the "Deed of Trust"), from McEwen Mining Inc., a Colorado corporation, Ticup LLC, a Nevada limited liability company, NPGUS LLC, a Nevada limited liability company, Nevada Pacific Gold (US), Inc., a Nevada corporation, WKGUS LLC, a Nevada limited liability company, Golden Pick LLC, a Nevada limited liability company, McEwen Mining Nevada Inc., a Delaware corporation, and Tonkin Springs LLC, a Delaware limited liability company, as trustors (collectively, the "Trustors"), to First American Title Company, as trustee ("Trustee"), for the benefit of Lender, as beneficiary (as successor-in-interest to Royal Capital Management Corp.), recorded in the Office of the Lincoln County Recorder, Nevada, on August 10, 2018, as Document No. 2018-155067.
